STATEMENT BY THE EAST AFRICA LAW SOCIETY ON INDEPENDENCE OF THE JUDICIARY AND DETERIORATION OF RULE OF LAW IN KENYA.

12[™] JANUARY 2024.

In recent weeks, we have witnessed an escalation of attacks on Kenya's judiciary through utterances by various

leaders including the President of the Republic of Kenya, H.E. Dr. William Ruto. These concerning utterances

erode confidence in the judiciary as well as its independence and paint as evil those who legally use courts to

challenge government excesses.

The East Africa Law Society is deeply concerned about these persistent attacks which also violate the principle

of separation of powers as enshrined in Kenya's Constitution as well as in various international instruments

including the United Nations Basic Principles on the Independence of the Judiciary, the Bangalore Principles of

Judicial Conduct, the Universal Declaration of Human Rights, the African Charter and the Commonwealth

(Latimer House) Principles of the three Arms of Government.

We join the Law Society of Kenya, the Judicial Service Commission and the Kenyan people in condemning the

attacks and urge government officials to refrain from interfering with judicial independence by engaging in

needless confrontations. It is our position that the rule of law is essential for the progress and prosperity of any

constitutional democracy, Kenya included. Where grievances are raised against any official in the judicial system,

we urge that the same be addressed fairly, procedurally and within existing legal frameworks.

In solidarity with our sister Bar, the Law Society of Kenya, we urge all our members from Kenya to participate

in the peaceful protests organised by the Society. We shall as a Regional Bar continue to champion and defend

the rule of law, human rights, good governance, accountability and independence of the judiciary in Kenya and

across the East African region.
